

**Consent, Waiver Release and Hold Harmless Agreement**

I, the undersigned, understand that Hillel Day School of Boca Raton, Inc. (the "School") is a non-profit educational institution, and is sponsoring the Hillel Basketball League in which adults may participate in a 10-game season (the "Program"). I understand that the School is providing space for the practices and games, appropriate equipment, and facilities on the School's premises for individuals who desire to participate in the Program. My participation in this Program is voluntary and at my own risk.

I recognize and acknowledge that there are certain risks of physical injury, and I agree to assume the full risk of any damages or loss which I may sustain as a result of my participating in any manner, in any and all activities connected with or associated with this Program. I further recognize and acknowledge that athletic activities involve such as basketball may involve strenuous exertion or potential body contact and may involve substantial risks of injury.

In consideration for the School providing and permitting the use of its premises, buildings, facilities, and equipment, I hereby agree to hold the School and its affiliates, subsidiaries, employees, managers, administrators, trustees, and parent companies harmless from any injury, loss, or damage relating in any way to my presence in and/or use of those facilities whether such injury, loss, or damage results from willful or negligent acts of the School or its agents, and further and with full knowledge of the consequences (i.e., that I am waiving my right to sue) expressly waive any and all liability on the part of the School from my entering, using, or leaving the School's buildings or facilities; using the School's equipment; and for any personal or professional actions or inactions by any person associated with or involved in the program. I further waive any claims for injury, damage, loss or theft of my property arising out of or in connection with my use of the facility or participation in the Program. I further agree that I will be responsible for any damage I do to the School facilities and equipment while participating in the program or to and from the events.

I have executed this Agreement with full knowledge of its significance, full appreciation of the risks associated with potential harm that could result from my presence at and/or use of the building, facilities, and equipment, and I understand and agree to the terms of this Waiver, which I execute voluntarily.
